- THE INSTALLATION OF CULVERT TILE SHALL BE MADE UNDER SUPERVISION OF AN INSPECTOR ACCORDING TO CHAPTER 13.42 OF THE ALGONA MUNICIPAL CODE.
- THE PERMIT FEE IS \$20 FOR THE FIRST 20 FEET, + \$.50 PER EACH ADDITIONAL FOOT.
- CATCH BASINS SHALL BE INSTALLED WHENEVER DEEMED NECESSARY BY THE PUBLIC WORKS SUPERINTENDENT.
- THE PUBLIC WORKS SUPERINTENDENT WILL DETERMINE THE SIZE, TYPE AND AMOUNT OF FILL TO BE INSTALLED.
- ALL CULVERT PIPE WILL BE CONCRETE, CMP (CORREGATED METAL PIPE), PLASTIC (30-34), OR N-12. CRUSHED ROCK OR PITRUN WILL BE USED UNDER THE CULVERT. DEPTH WILL VARY FROM 6" TO 12".
- ALL DRIVEWAYS REQUIRE A MINIMUM OF 30 FEET OF CULVERT.

Chapter 13.42 CULVERT TILE

13.42.010 Permit – Requirement.

It is unlawful to install any tile or pipe in any ditch, upon any right-of-way, street or alley, or upon public property belonging to or under the jurisdiction of the city without first obtaining a permit from the city. (Ord. 947-04 § 2 (part)).

13.42.020 Permit – Fee.

The above permit shall be in the amount set forth in Chapter 2.50 of this code. (Ord. 947-04 § 2 (part)).

13.42.030 Physical specifications.

Material type, size and location will be at the discretion on the director. (Ord. 947-04 § 2 (part)).

13.42.040 Specification determination by authorized inspector.

Subject to the requirements set forth in Sections 13.42.030 the size of tile or pipe, and fill, and base and foundation, kind and amount, shall be determined by the duly authorized inspector. (Ord. 947-04 § 2 (part)).

13.42.050 Construction requirement.

All tile or pipe shall be made of concrete, or material of equal strength accepted by a duly authorized inspector. (Ord. 947-04 § 2 (part)).

13.42.060 Violation – Penalty.

A. Any person found guilty of violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be fined in a sum up to three hundred dollars or imprisonment for not more than ninety days or both.

B. Each day of continuing violation of the terms of this chapter shall be considered a new offense. (Ord. 947-04 § 2 (part)).

13.42.070 Abatement of violation – Civil penalty to recover costs.

Whenever judgment is rendered against any person, firm or corporation finding him guilty of a violation of this chapter, it is the duty of the court before whom the conviction is had, in addition to imposing the penalty provided in Section 13.42.060, to order the defendant or defendants in such fashion to remove such tile or pipe; and if the same is not done by such offender within sixty days, the same shall be abated and removed under the direction of the chief of police or any other officer authorized by the order of the court, which order shall be entered upon the docket of the court and made a part of the judgment in such action; and in the event of any action taken by the police chief or any other such officer, the same shall be at the expense of the defendant and after inquiry into and estimating the sums necessary to defray the expense of such abatement, the court shall enter judgment against the defendant in such amount.
